## Final Report on Bylaws Amendments Process, 2016 (second ballot)

December 2, 2016

On September 29, 2016, the Pacifica National Board of 18 voted on three proposed bylaws amendments. They were as follows: *Replacing one LSB Town Hall with LSB Fundraiser*, *Changing frequency of delegate elections and term of delegates*, and *Reconciling submitting and posting proposed bylaws amendments*. Two of the three proposed bylaws amendments were approved by the PNB.

The KPFT Delegates met on November 9, 2016 to consider the two proposed bylaws amendments approved by the PNB.

The WPFW Delegates met on November 9, 2016 to consider the two proposed bylaws amendments approved by the PNB.

The KPFK Delegates met on November 13, 2016 to consider the two proposed bylaws amendments approved by the PNB.

The KPFA Delegates met on November 19, 2016 to consider the two proposed bylaws amendments approved by the PNB.

[Note that the WBAI Delegates did not vote on any of the proposed bylaws amendments by the November 27, 2016 deadline]
